The tuition waiver benefit will not apply unless registration is processed through this form.

- 1. Eligibility requirements (ORS 341.518):
 - a. Must be 65 years or older AND a Oregon resident as of the start of the term
 - As of 2nd week of the course the instructor & department must verify space is available in the course
 - Lower-division 100 or 200 level collegiate credit courses qualify for the waiver (see catalog)
 - Course prerequisites must be satisfied prior to enrollment
 - The tuition waiver can be used to cover a maximum cost of 8 credits per term e.
 - f. The student is responsible for paying all course fees

 - Forms are accepted no earlier than the 2nd week of the term and no later than the 4th week **Do NOT enroll in the course online via My Chemeketa;** that will disqualify you from receiving the waiver
